on the proposal for a Council decision on the conclusion of the Additional Protocol to the Agreement establishing an Association between the European Economic Community and Turkey following the enlargement of the European Union (9617/2005 – COM(2005)0191 – C6-0194/2005 – 2005/0091(AVC))

(Assent procedure)

The European Parliament,

- having regard to the proposal for a Council decision (COM(2005)0191)¹,
 - having regard to the text of the Council (9617/2005),
 - having regard to the request for assent submitted by the Council pursuant to Article 300(3), second subparagraph, in conjunction with Article 300(2), first subparagraph, second sentence and Article 310 of the EC Treaty (C6-0194/2005),
 - having regard to Rules 75, 83(7) and 43(1) of its Rules of Procedure,
 - having regard to the recommendation of the Committee on Foreign Affairs (A6-0241/2005),
1. Gives its assent to conclusion of the Additional Protocol to the Europe Agreement with Turkey;
 2. Instructs its President to forward its position to the Council and Commission, and to the governments and parliaments of the Member States and of Turkey.
