FOR SEIZED PROPERTY RESTITUTION / COMPENSATION

Based on Article 42/2 of the Law on Seized Property Restitution and Compensation (Official Gazette of the Republic of Serbia No: 72/11) I am submitting a request for seized property restitution or compensation and giving the following information:
